The International Accreditation Forum (IAF) and its Accreditation Body (AB) members invest significant effort and resources to maintain the integrity and consistency of the IAF Multilateral Recognition Arrangement (MLA) through a peer evaluation process. This report sets out the detailed activities that are carried out as part of the peer evaluation process, to ensure that regulators, specifiers, and businesses can have confidence in the MLA.

The IAF MLA

The purpose of the IAF MLA is to provide users in economies with Accreditation Bodies that are IAF MLA signatories with the assurance that equivalent Certification and Validation/Verification Bodies in other economies operate to the same standards as those in their own economies for certificates and statements in the fields of:



Accreditations granted by IAF MLA AB signatories are recognised worldwide based on their equivalent accreditation programmes, therefore reducing costs and adding value to industry and consumers.

The MLA contributes to the facilitation of world trade by eliminating technical barriers. IAF works to find the most effective way of achieving a single system to meet the objective of "Accredited once, accepted everywhere".



The IAF MLA Mark



Accreditation Body Logo

The IAF MLA Mark can be used by ABs to demonstrate their status as a signatory to the IAF MLA. If approved by the AB, accredited Certification Bodies (CBs) and Validation/Verification Bodies (VVBs) can also use the IAF Mark in combination with the accreditation symbol on their certificates, provided that the certificates are issued under a granted IAF MLA scope.

The IAF MLA Mark demonstrates that the certificate has been issued by a CB or VVB that is accredited by an IAF MLA signatory and is thus traceable to the highest authority. It is an assurance that the certificate and the issuing body are of a high standard of competence and may be trusted, as they are recognised as complying with the same set of standards at the global level.

Scope of the IAF MLA

The IAF MLA is composed of IAF MLA main scopes and corresponding IAF MLA sub-scopes.

Certificates issued on the basis of an IAF MLA main scope are considered "equally reliable" because the conformity assessment bodies conform to the same standards.

Certificates issued on the basis of an IAF MLA sub-scope are considered 'equivalent' as they are based on the same IAF endorsed standards or sector schemes. Sub-scopes are divided into two categories (Level 4 and Level 5). Level 4 sub-scopes are IAF endorsed normative documents used by ABs in conjunction with main scope documents to assess a CB's competence in a specific sector. Level 5 sub-scopes are IAF endorsed normative documents used by CBs.

Level 1 is the endorsed normative document for Accreditation Bodies

Level 2 and 3 are the main-scopes consisting of accreditation programs and endorsed normative documents

Level 4 and 5 are the sub-scopes consisting of applicable documents and endorsed normative documents

As a supplement, IAF has developed a fast-track sub-scope evaluation process based on the evaluation of the Global Food Safety Initiative (GFSI) benchmarking process of GFSI sector schemes. A corresponding Memorandum of Understanding (MoU) between IAF and GFSI was signed to facilitate the acceptance of GFSI benchmarked schemes as IAF MLA sub-scopes.

Signatories to the IAF MLA

The IAF MLA has been structured to build on existing and developing regional MLAs established around the world. Therefore, IAF has formally recognised the MLA programs of five Regional Accreditation Groups (RAGs):



ABs recognized under these Regional MLAs may apply to IAF for recognition under the IAF MLA on the basis of the acceptance of the mutual recognition arrangements established within these organisations.

Membership of the IAF MLA is facilitated by membership in the recognised RAGs' MLAs (AFRAC, APAC, ARAC, EA or IAAC) for recognised programs. IAF members who are also signatories of these regional MLAs can be accepted into the IAF MLA for recognised programs. Originally, unaffiliated ABs applied directly to IAF to become an IAF MLA signatory. Since the end of 2018, there have been no unaffiliated IAF Member accreditation bodies as all IAF AB members are now also members of a RAG.




IAF MLA Annual Report 2020

The number of signatories to the IAF MLA has grown in recent years, providing confidence to businesses and regulators in a greater number of economies. 


Number of signatories for Validation/





A total of **10,400** CBs and V&Vs are currently accredited, an increase of **2%** since 2019.

These numbers reflect the total number of sub-scopes covered by accredited CABs in the RAGs, including where a CAB is accredited for more than one sub-scope.

Peer Evaluation Process

ABs are admitted to the IAF MLA only after a stringent evaluation of their operations by a peer evaluation team that is charged to ensure that the applicant complies fully with both the international standards and IAF requirements. IAF, and its AB members, invest significant costs and resources to ensure and maintain the integrity of the MLA through robust peer evaluations. The MLA and its signatories are under constant review. The peer evaluation process is ongoing and extensive, covering all economies in a regular programme.



The IAF MLA is under constant review to better serve the needs of stakeholders. IAF conducted a number of evaluations of private sector schemes to eventually become IAF MLA sub-scopes.




MLA Monitoring and Improvement Activities

IAF is committed to monitoring and reviewing the MLA to ensure that it continues to meet the needs of stakeholders. In addition to consulting widely with stakeholders, IAF carries out a number of programmes and activities to continuously improve the value and effectiveness of the MLA.



Complaints provide a valuable mechanism for receiving feedback relating to the effectiveness of the MLA. This often confirms that the MLA is working effectively and that the process in place is suitably robust. It can also provide information that can be used to improve areas of the MLA.

The following numbers of complaints were raised during this period:



Following the declaration of COVID-19 as a pandemic and the imposition of social distancing and travel restrictions, IAF immediately began developing resources in response, working closely with stakeholders to address their needs. In collaboration with ILAC and the Regional Accreditation Groups, a framework of measures was developed to allow assessments and peer evaluations to be performed remotely, guaranteeing the maintenance of a high level of competence and harmonization.

COVID-19 RESPONSE

Resources published in 2020 include:

• an <u>IAF Statement on COVID-19</u>, which highlights relevant IAF documents on extraordinary events and the use of information and communications technology in audits and assessments;

• a series of <u>COVID-19 FAQs</u> endorsed at the 2020 IAF General Assembly, which helps certification-based stakeholders (certified clients, certification bodies, accreditation bodies, scheme owners and regulators) maintain a harmonized approach; and

• an <u>IAF-ILAC Statement re Delayed Evaluations - March 2020</u>, which provides guidelines that ensured the consistent transition of all IAF MLA and ILAC MRA signatories to the latest version of ISO/IEC 17011.

A <u>COVID-19 hub</u> on the IAF website contains links to all current resources.

The IAF MLA Management Committee and ILAC Arrangement Management Committee continued meeting remotely following the imposition of travel restrictions. Additionally, IAF collaborated with a number of other international organizations to share experiences with working remotely and highlight the role of conformity assessment in supporting health and safety during the pandemic, including UNIDO, OECD, ISO/CASCO and GFSI.

Improvement Activities

IAF consults widely with stakeholders in developing accreditation programs, and it works to deliver the best standard of conformity assessment in order to provide stakeholders with a value added outcome. The following activities were carried out to improve the MLA in 2020:





Collaboration with ILAC is continually improving to a point where only IAF/ILAC Joint Management Committee meetings are held and there are no separate meetings of the IAF MLA Management Committee and the ILAC AMC. This provides a better understanding of the few different requirements and the many commonalities in the MLA area between the two organisations. Changes to the IAF membership on the Joint Management Committee were implemented on 01 January 2021 to achieve more balanced representation from both organisations.

EREUROPEAN

- The EA peer evaluation process is under continuous review. Regulation (EC) No 765/2008 reinforces
 the role of EA and its peer evaluation role in both voluntary and regulated sectors. EA supports and
 harmonizes the implementation of stringent rules to achieve consistency throughout Europe, as well as
 greater transparency and acceptability to all, including national authorities. The peer evaluation process
 is also further strengthened to accommodate the specific needs in regulatory fields in order to reassure
 regulators and stakeholders that ABs' technical competence is thoroughly assessed.
- The Multilateral Agreement Council (MAC) project to re-engineer the peer evaluation system, one of the key actions of the EA Strategy 2025, continued to progress in 2020 and is nearing its goal.
- In the beginning of 2020, the EA MAC Management Group (MG) consolidated the following papers, based on the comments received from MAC members:
 - MAC Secretariat needed competences for undertaking further activities under its umbrella;
 - Principles related to witnessing carried out in advance of the head office evaluation;
 - ♦ Role of Task Force Group (TFG) vs Secretariat in the report review; and
 - ♦ Criteria to be fulfilled by the MAC members.

The principles contained in those papers were endorsed by the MAC, which agreed to include them in the next revision of EA-2/02: EA Procedure for the Evaluation of a National Accreditation Body (NAB).

 The MAC MG also prepared a paper, commented on by MAC members, on a fast-track consulting mechanism with the technical infrastructure (i.e. technical committees) needed in certain technically challenging circumstances.

- An EA MAC MG TFG concluded a draft document to support the use of a risk-based approach when designing peer evaluations. Following the EA MAC MG's consideration of important areas to test the provisions set out in the document, 4 Team Leaders were invited to perform a validation exercise for recent cases where the standard document review has already been performed and the team and their specific mandates were established. The outcome of the validation exercise will be reviewed by the MAC MG in 2021.
- Further discussions will be held on the few topics not yet considered.

APAC

 In 2020, APAC approved APAC MRA-009 Performing Remote Evaluations – Requirements and Guidance, which is being implemented to enable APAC evaluations to continue despite the inability to travel due to the COVID-19 travel restrictions.

IAAC

The IAAC approved its five-year strategic plan, which includes actions to promote the IAAC MLA, IAF MLA and ILAC MRA among members and relevant stakeholders in the region. The IAAC MLA procedures and documents were reviewed and changed to allow IAAC to carry out remote peer evaluations during the COVID-19 pandemic.



- An accredited Conformity Assessment Bodies and ARAC Stakeholders Community Awareness Workshop
 was conducted on 26 February 2020 in Amman, Jordan, with the participation of the Jordanian Ministry
 of Industry and Trade and more than 70 participants from the CBs and regulatory authorities in Jordan.
 During this workshop, the participants stressed the role that ARAC plays in the development of the
 accreditation and conformity assessment infrastructure in Jordan. The objective of the workshop was to
 provide stakeholders in Jordan with a better understanding of the value of accreditation and accredited
 services, and in particular, to encourage regulators to recognize and accept accredited conformity
 assessment results covered under the IAF MLA.
- Within the framework of the cooperation between ARAC and Arab Food Safety Initiative for Trade Facilitation [SAFE], and on the occasion of World Food Safety Day on 07 June 2020 under the theme "Food safety, everyone's business" and World Accreditation Day on 09 June 2020 focusing on how accreditation supports food safety, ARAC and SAFE organized the Arab Accreditation and Food Safety Week [AAFSW] during the period 06-10 June 2020 under the theme "Together towards enhancing the accreditation and food safety infrastructure to protect the consumer in the Arab region". Several online activities held during the AAFSW highlighted ways to further develop the infrastructure for accreditation and food safety in the Arab region and its pivotal role in protecting the Arab consumer. In addition, capacity-building activities were implemented to strengthen the ARAC and SAFE members' competencies.



- Due to the pandemic, AFRAC successfully held its mid-term and General Assembly meetings via videoconference in June and September 2020, respectively
- AFRAC's AB members shared experiences in coping with COVID-19 during the General Assembly meeting in September 2020, which was very informative and fed into the development of the AFRAC document

- on remote assessments, to allow evaluations to continue during the COVID-19 pandemic
- The new and improved AFRAC website was successfully launched in November 2020. It includes various on-line capabilities such as voting, meeting registrations, a complaints/feedback/appeals mechanism, and committee members' secure access to meeting documents, minutes, resolutions, documents posted for comment periods, etc.
- AFRAC continues to promote IAF and the acceptance of the MLA through influencing the relevant Sanitary and Phytosanitary (SPS) requirements and Technical Barriers to Trade (TBT) requirements. As such, AFRAC continues to participate in the finalisation of the African Quality Policy as well as the formulation of the African SPS policy. These policies recognise the role of accredited CBs in support of regional trade



- Due to the pandemic, SADCA successfully held its Mid-Term and General Assembly meetings via videoconference in August and September 2020, respectively
- SADCA applied to IAF for recognition as a RAG. This international recognition will be a key milestone in enabling full integration of the South African Development Community (SADC) region into the world trading system as it will enhance regional and global market access, hence enabling the acceleration of economic growth within the SADC region
- SADCA continues to promote the acceptance of accredited conformity assessment results to
 underpin the SADC regulatory requirements. As part of the SADC Standardisation, Quality assurance,
 Accreditation and Metrology (SQAM), SADCA provided input to the standards, metrology and the SADC
 regulatory forum on matters of accreditation and the mutual recognition of conformity assessment
 results



ΕA

- In 2020, two refresher peer evaluator training sessions were organized remotely:
 - The first session held on 17-18 November 2020 was dedicated to testing and calibration. The trainers were Tuija Sinervo (FINAS) for the testing group, Ilan Landesman (ISRAC) for the calibration group and Daniela Ionescu, EA MAC Secretary, for the general aspects related to the peer-evaluation process. Nearly 30 participants from EA NABs discussed harmonisation issues for clauses of ISO/IEC 17011:2017 and ISO/IEC 17025:2017 before gathering into two specific workshops for testing or calibration
 - The second refresher training session, held on 15-16 December 2020, focused on inspection and certification of products. The trainers were Ian Ronksley (UKAS) for the product certification group, Gokhan Birbil (TURKAK) for the inspection group and Daniela Ionescu for the aspects related to the peer-evaluation process. 26 participants from EA NABs discussed harmonisation issues for clauses of the ISO/IEC 17011:2017 before being split into two specific workshops for inspection or certification of

products

- A newcomer training session scheduled on 09-11 December 2020 was cancelled because it was agreed that it is inappropriate to train and approve new evaluators remotely. This session is postponed until 21-23 June 2021, provided that it can be held as a face-to-face training session.
- Other training sessions:
 - Before the COVID-19 outbreak, the second session (first session in December 2019) of a train-the-trainer workshop on ISO/IEC 17029: Conformity Assessment -- General requirements for bodies performing validation and verification activities was hosted on 29 January 2020, near Paris by the EA Secretariat. 13 representatives from EA NABs participated in this additional workshop. The trainers were Nathalie Savéant (COFRAC, France) and Stefanie Vehring (VdTÜV, Germany).
 - A train-the-trainer workshop jointly organised on 07 October 2020 by the EA Harmonisation (HHC) and Certification (CC) Committees was dedicated to the evaluation of schemes. A morning session focused on revised EA-1/22: Procedure and Criteria for the Evaluation of Conformity Assessment Schemes by EA Accreditation Body Members, whereas an afternoon session considered a document developed by the EA CC on selection of standards between ISO/IEC 17021-1 and ISO/IEC 17065. Each half-day session included a plenary introduction and a breakout session, followed by feedback from the groups and a final conclusion. Some 80 persons from EA NABs' staff in charge of sector schemes and representatives from EA Recognised Stakeholders, such as Bioenergy Europe, the Independent International Organisation for Certification (IIOC), the International Certification Network IQNet and NB-Rail, took part in this remote training. The trainers were Gabriel Zrenner (HHC Chair), Sjaak Hendriks (HHC Vice-Chair), Kevin Belson (CC Chair) and Casper van Erp (RVA, CC WG Environment convener).
 - Another online training session on the revised EA-2/17: EA Document on Accreditation for Notification Purposes was organised by the HHC on 03 December 2020. This training session enabled nearly 80 participants from EA NABs and TIC Council, the Association of the global independent Testing, Inspection and Certification (TIC) industry, to gain familiarity with the content of the new version of EA-2/17, including the concept of the preferred standard and its usage, as well as to be able to introduce the new document in their respective NAB including informing their colleagues and assessors. The trainers were Gabriel Zrenner, Leopoldo Cortez (IPAC, Portugal), Sjaak Hendriks (RvA, Netherlands), Yannick Le Tallec (Group of Notified Bodies regarding the Construction Products Regulation), Maria Papatzikou (ESYD, Greece) and Hélène Tagzout (COFRAC, France), who led several plenary introductions, including a presentation of the Accreditation for Notification (AfN) project, and concrete group exercises in breakout sessions.
 - An EA Workshop on the Accreditation of Conformity Assessment Bodies (CABs) in the Regulated Railway Sector was also provided on 08 December 2020 to EA members and stakeholders of the EA Certification and Inspection Committees. Several speakers from the European Commission, ERA (EU Agency for Railways), NB-Rail and EA made presentations about assessment of CABs in the railway sector, accreditation of Notified Bodies regarding the Interoperability Directive (IOD), and accreditation of CSM (Regulation on the common safety method for risk evaluation and assessment) assessment bodies, accreditation and recognition of ECM (Regulation on a system of certification of entities in charge of maintenance for freight wagons) certification bodies under Regulation EU 779/2019. The EA Executive Secretary introduced and concluded the workshop, which gathered 47 participants from EA NABs and Recognised Stakeholders such as CEN/CENELEC, IIOC, IQNet and TIC Council.
 - EA organised the first Virtual Conference on Accreditation in light of Cybersecurity, Artificial Intelligence and Digitalisation on 26 November 2020. Nearly 300 participants could listen to four high-profile speakers from the European Union Agency for Cybersecurity (ENISA), the European Commission DG CONNECT, DNV GL Business Assurance and UKAS, the UK NAB, sharing the state of play and the latest developments in the areas of cybersecurity and artificial intelligence, as well as the impact of digitalisation on conformity assessment and accreditation.

APAC

 During 2020, APAC delivered five peer evaluator training activities, including three on remote evaluation and one on evaluation for the scope of product certification. In addition, APAC undertook four online training courses on assessment for person certification (ISO/IEC 17024), calibration laboratories and measurement uncertainty (ISO/IEC 17025), energy management system (EnMS) certification and food safety management system (FSMS) certification.

IAAC

- IAAC launched its first IAAC Peer Evaluators Virtual Forum on 16 July 2020. 118 IAAC Peer Evaluators participated in
 the virtual meeting, which included an explanation of the proposed changes to the IAAC peer evaluation procedure,
 performing remote peer evaluations and accreditation of flexible scopes. A new Guide for Remote Peer Evaluations
 was reviewed. The Virtual Forum is a new way for IAAC to hold regular meetings with peer evaluators with the aim of
 harmonizing practices and keeping them updated on document changes and MLA developments.
- IAAC held its second Peer Evaluators Virtual Forum on 05 October 2020. 116 IAAC peer evaluators participated in the training session which addressed the Frequently Asked Questions on the implementation of ISO/IEC 17011 published by the IAF/ILAC Joint Working Group A-Series, a review of the approved MLA procedure to carry out remote peer evaluations, and a discussion on the guidance document to conduct remote peer evaluations. These virtual sessions allow peer evaluators to provide feedback and ask questions on the new procedures that are being implemented by IAAC.

ARAC

- Online Regional Workshop on how to get ready for ARAC peer evaluation and filling the new version of the selfassessment report IAF/ILAC A3-03/2020:
 - Within the framework of the implementation of the ARAC Capacity Building program and in order to support non-ARAC MLA signatory members to start their peer evaluation process, an online regional workshop was held on 21 and 22 July 2020 for the ARAC AB member representatives, including their quality managers, on how to get ready for an ARAC peer evaluation and filling out the new version of the self-assessment report IAF/ILAC A3-03/2020 "Template report for the peer evaluation of an Accreditation Body based on ISO/IEC 17011:2017".
 - The main objectives of this regional workshop were to:
 - » Provide updated information on the joint IAF/ILAC documents used for evaluations
 - » Provide an overview on the conditions and the needed documents to be prepared to apply to join the ARAC MLA
 - » Learn the essentials on the main sections of the latest version of IAF/ILAC A3 used for the application and peer evaluation process
 - » Provide participants with knowledge and skills to complete the template report on the performance of the accreditation body as part of the application documents for evaluation by ARAC
 - » Exchange experiences and knowledge through group discussions on useful lessons from previous practice.
- Establishment of ARAC E-learning platform:
 - Taking into consideration the COVID-19 outbreak, which reveals the benefits and need for the e-trainings, ARAC established its first e-learning platform by completing the materials of the first ARAC E-learning training course on new accreditation scheme development and risk based assessment approach for the Accreditation Bodies
 - The main objectives of this regional workshop were to:
 - » Review key aspects of risk management
 - » Recognize the risk based thinking in ISO/IEC 17011:2017 and the different accreditation standards
 - » Reach a common understanding of the expected outcome of the risk management process
 - » Review the possible tools to confirm the compliance of the Accreditation Body's ability to address risks and opportunities in its operation
