EA Resolution 2026 (60) 02

The General Assembly, acting upon recommendation from the Executive Board, adopts the Implementation Plan of the EA Strategy 2030 as indicated in EAGA(26)05-C-04.

EA Resolution 2026 (60) 03

The General Assembly hereby resolves that, going forward, the number of votes as well as the total votes cast in favour, against, or abstaining in the election of persons in EA Committees, Council, and other groups, shall be disclosed to the Committee / Council / Group concerned.

EA Resolution 2026 (60) 04

The General Assembly, acting upon recommendation from the Executive Board, adopts:

- the Statutory Auditor's Report on the financial statement for 2025 (Documents EAGA(26)05-C-12, EAGA(26)05-C-13 and EAGA(26)05-C-14);
- the Statutory Auditor's Special Report on regulated agreements (Document EAGA(26)05-C-15);
- the Statutory auditor's attestation on the eligibility of expenditures regarding the Operating Grant 2025 (English version Document EAGA(26)05-C-17) and French version with annexes (Document EAGA(26)05-C-16).

EA Resolution 2026 (60) 05

The General Assembly accepts the Financial Oversight Committee's Report on EA accounts for 2025 (Document EAGA(26)05-C-19) and endorses the Executive Board's response to the Financial Oversight Committee's Report on EA 2025 Accounts (Document EAGA(26)05-C-20).

EA Resolution 2026 (60) 06

The General Assembly, acting upon recommendation from the Executive Board, approves the financial accounts for 2025 (Document EAGA(26)05-C-18), including Annex 2 of the activity-based budget. The result of 10.179 Euro shall be transferred to the EA reserves.

EA Resolution 2026 (60) 07

The General Assembly grants discharge from liability to the members of the Executive Board for the policy conducted by them during the financial year 2025 in accordance with Article 19.5 of the Articles of Association.

EA Resolution 2026 (60) 08

The General Assembly, acting upon recommendation from the Executive Board, approves the 2026 Q1 forecast (Document EAGA(26)05-C-34) and mandates the Executive Board to adjust the budget, if necessary.

EA Resolution 2026 (60) 09

The General Assembly, acting upon recommendation from the Executive Board:

- approves the proposed budget for 2027 (Document EAGA(26)05-C-23) and membership fee schedule for 2027 (Document EAGA(26)05-C-24);
- mandates the Executive Board, in compliance with EA-1/20 A:2022, to review, adjust and present the revised budget 2027 and the fee schedule 2027 to the General Assembly for endorsement. Endorsement may be realised by electronic ballot, if necessary.

EA Resolution 2026 (60) 10

The General Assembly, acting upon the recommendation from the Executive Board, approves the Action Plan 2027- 2030 dated 17 March 2026 (Document EAGA(26)05-C-08), and mandates the Executive Board to revise the Action Plan 2027- 2030, if necessary.

EA Resolution 2026 (60) 11

The General Assembly, acting upon the recommendation from the Executive Board, approves the Work Programme for 2027 dated 21 April 2026 (Document EAGA(26)05-C-21), and mandates the Executive Board to revise the Work Programme 2027, if necessary.

EA Resolution 2026 (60) 12

The General Assembly, acting upon recommendation from the Executive Board, gives mandate to the Secretariat to replace ILAC and IAF with GLOBAL ACI in all EA documents.

EA Resolution 2026 (60) 13

The General Assembly, acting upon recommendation from the Certification Committee, agrees that the application of the following Level 4 standards shall be considered under the EA MLA:

- ISO/IEC 27706: *Information security, cybersecurity and privacy protection — Requirements for bodies providing audit and certification of privacy information management systems (ex 27006-2) — Published 2025*

- ISO/TS 21030: *Educational organizations — Requirements for bodies providing audit and certification of educational organizations' management systems* – Published 2023
- ISO 14019-4: *Principles and requirements for bodies validating and verifying sustainability information* — Published 2026
- ISO 14066: *Environmental information – Competence requirements for teams validating and verifying environmental information* — Published 2023
